The mentor recorders may not be running the meet they will be available to assist the meet recorder if needed.

#### Funding:

In order to get the most funds to our officials we will be operating on a tight budget this year. If flying, we ask that <u>you make your own arrangements</u> as early as possible to take advantage of any possible seat sales. We will be paying your gas to the competition or airfare whichever is less. ODC will pay up to \$45 per day per diem. Please keep all your accommodation, airfare and or gas receipts and submit them to BCSSA ODC <u>unless you are the chief and then your accommodation and meal expenses must be submitted to the hosting club for re-imbursement</u>.
