Monthly face-to-face Executive meetings are recommended as the best way for clubs to stay engaged, informed, organized and productive.

BC Societies Act

A new Act will be introduced this November. It will impact all not-for-profit organizations. Be informed: visit the registry website:

Note: organizations will have up to 2 years to comply with the changes required by the new Act. The BCSSA Executive Director will offer guidance in this area as details are known.

In the meantime, make sure your Annual Society Reports are up-to-date.

Coach Security Clearance Policy:

August - September

BCSSA requires clubs have a Security Clearance Policy for Coaches.

Review your club policy and have a process in place to ensure compliance.

Have completed clearances returned to the club but make sure these are handled securely as the information is confidential.

Insurance Renewal:

October 1

New certificates will be e-mailed to club Presidents.

D&O Insurance Renewal (for clubs)

October 15

BFL Canada will be in touch with clubs directly.

BC/SSC Membership Fees - Billing # 1:

October 1

All clubs will be invoiced 100.00 annual club affiliation fee.

Clubs collecting fees on-line through a Peloton account will transfer funds electronically.

Clubs collecting fees manually will be invoiced by the BCSSA.
