#### Recorders

The mentor recorders may not be running the meet they will be available to assist the meet recorder if needed.

#### Funding:

In order to get the most funds to our officials we will be operating on a tight budget this year. If flying, we ask that <u>you make your own arrangements</u> as early as possible to take advantage of any possible seat sales. We will be paying your gas to the competition or airfare whichever is less. ODC will pay up to \$45 per day per diem. Please keep all your accommodation, airfare and or gas receipts and submit them to BCSSA ODC <u>unless you are the chief and then your accommodation and meal expenses must be submitted to the hosting club for re-imbursement</u>. This is in keeping with SSC ODC policy and is good training for our provincial referees for reimbursement of expenses. Please Note: The online chief referee report <u>must</u> also be done before any receipts will be paid out.

The hosting club will be reminded that this is their responsibility. Names of officials in red are fully funded officials by ODC not by the host club.
