This past season saw much success both on and off the ice. Our skaters did well at National events as highlighted in the Athlete Development Committee report. The Coaching Committee was able to provide more direct assistance to representative coaches in supporting our skaters at targeted events and this committee will focus on providing opportunities for professional development this coming season. The Officials Development Committee focused on supporting clubs with assigned officials to targeted events within the Province this past season. The expectation to see out-of-province officials' support this coming season will aid our developing officials with their professional development.

The Association was most fortunate in welcoming Keara Maguire, in the position of part-time Sport Manager, to support our committees meet their goals and objectives. Thank you, Keara, for this seamless transition. This past fall, the Association was required to challenge an initial decision by Canadian Sport Institute to continue their Enhanced Excellence Funding primarily supporting our Academies. The resulting face-to-face interview – with very strong support by Yves Hamelin, Director of the Calgary Olympic Oval, and Ian Moss, CEO of Speed Skating – required many hours of staff pre-interview activities. You will hear of the very successful 2nd year of our Sport Academies expanded this past season to four locations throughout the Province. I commend the committees in the fiscal management of their budgets and appreciate the Board supporting our other Administration and Operating costs.
